- 4. we understand that IMDA is publishing or providing the List of Contractors as a guide for building owners, management corporations or any other party who is eligible for IMDA's Fibre Ready Scheme (each an "Owner"), who may need assistance to engage a contractor, and IMDA's agreement to our Request (if applicable) does not constitute or represent any form of endorsement or recommendation by IMDA of our services and work and we undertake not to hold ourselves out or represent in any way to any person that we are endorsed or recommended by IMDA in any way;
- 5. we understand if any Owner decides to engage us, they shall negotiate the price and extent of the work with us on a private basis and IMDA is not privy to this private engagement;
- 6. we understand that the existing personal data protection laws, rules and regulations do not apply to the information we have provided herein and the information we may provide to IMDA from time to time pursuant to the Request;
