**NOTIFICATION OF APPROVAL: MODIFICATION OF OPENNET PTE LTD'S ("OPENNET") INTERCONNECTION OFFER ("ICO")**

1. Please refer to the following documents:
  - (i) IDA's direction dated 15 February 2013, directing OpenNet to modify its proposed ICO modifications to incorporate specific drafting language in Schedules 12C (Co-Location Space & Service in New Co-Location Room) and 15 (Charges) in relation to OpenNet's proposed Co-Location Space & Service in New Co-Location Room<sup>1</sup> ("**IDA's 15 February 2013 Direction**");
  - (ii) IDA's direction dated 15 August 2013, directing OpenNet to modify Schedule 15 (Charges) to incorporate the IDA-determined charges for Co-Location Services; and to propose modifications to its ICO as are necessary to give effect to IDA's direction<sup>2</sup> ("**IDA's 15 August 2013 Direction**"); and
  - (iii) OpenNet's proposed modifications to its ICO, as submitted by OpenNet to IDA on 29 August 2013<sup>3</sup>.

2. Having reviewed OpenNet's proposed modifications, IDA has assessed that the modifications are in accord with IDA's 15 August 2013 Direction.
3. Accordingly, IDA hereby approves the amended ICO ("**Approved ICO**") to take effect from the date of this notification, with the exception of the applicable charges under Schedule 15 (Charges) for Co-Location Space and Power Charges offered under Schedule 12C (Co-Location Space & Service in New Co-Location Room), which are to be applied retrospectively from the date of IDA's approval of Schedule 12C, i.e. 15 February 2013.
