1. The Licensee shall ensure that the arts entertainment and its related exhibits (including any multimedia content) are in accordance with the materials submitted to the Licensing Officer e.g. script/program/set list/synopsis/declaration;
2. The Licensee shall ensure that the arts entertainment and its related exhibits (including any multimedia content) are within the content guidelines for the 'General' classification rating, as per the Arts Entertainment Classification Code issued by the Licensing Officer;
3. The Licensee shall ensure that the contents of the publicity materials for the arts entertainment are in accordance with the Singapore Code of Advertising Practice as administered by the Advertising Standards Authority of Singapore (ASAS), and are not suggestive or potentially offensive;
4. The Licensee shall ensure that the licence and any information pertaining to the arts entertainment are produced upon request by any authorised officer;
5. The Licensee shall comply with other relevant laws including the Sedition Act and the Penal Code;
6. The Licensee shall comply with the Tobacco (Control of Advertisements and Sale) Act and its subsidiary legislations and ensure that no tobacco products are advertised, promoted, sold, offered for sale or supplied in any manner during the arts entertainment.
7. The Licensee shall comply with any additional conditions stipulated by the Licensing Officer and/or the Police in accordance with Section 10 of the Public Entertainments Act.

3. The Licensee shall ensure that the 'Advisory' rating and consumer advice issued are reflected in the publicity materials and at the ticketing booths and the arts entertainment venue;
4. The Licensee shall ensure that the contents of the publicity materials for the arts entertainment are in accordance with the Singapore Code of Advertising Practice as administered by the Advertising Standards Authority of Singapore (ASAS), and are not suggestive or potentially offensive;

2. The Licensee shall ensure that the arts entertainment and its related exhibits (including any multimedia content) are within the content guidelines for the 'Advisory 16' classification rating, as per the Arts Entertainment Classification Code issued by the Licensing Officer;
3. The Licensee shall ensure that the 'Advisory 16 years and above' rating and consumer advice issued are reflected in the publicity materials and at the ticketing booths and the arts entertainment venue;
4. The Licensee shall ensure that the contents of the publicity materials for the arts entertainment are in accordance with the Singapore Code of Advertising Practice as administered by the Advertising Standards Authority of Singapore (ASAS), and are not suggestive or potentially offensive;

1. The Licensee shall ensure that the performance and its related exhibits (including any multimedia content) are in accordance with the materials submitted to the Licensing Officer e.g. script/program/set list/synopsis/declaration;
2. The Licensee shall ensure that the arts entertainment and its related exhibits (including any multimedia content) are within the content guidelines for the 'R18' classification rating, as per the Arts Entertainment Classification Code issued by the Licensing Officer;
3. The Licensee shall ensure that no individual below the age of 18 be permitted to perform in any arts entertainment without the consent of his parent or guardian;
4. The Licensee shall ensure that the R18 rating and consumer advice issued are reflected in the publicity materials and at the ticketing booths and the arts entertainment venue;
5. The Licensee shall ensure that no person below 18 years of age is permitted to view the arts entertainment;
6. The Licensee shall ensure that the contents of the publicity materials for the arts entertainment are in accordance with the Singapore Code of Advertising Practice as administered by the Advertising Standards Authority of Singapore (ASAS), and are not suggestive or potentially offensive;
7. The Licensee shall ensure that the licence and any information pertaining to the arts entertainment are produced upon request by any authorised officer;
