#### **SCHEDULE 15**

#### **CHARGES**

NOTE: IDA's directed modifications within Schedule 15 cover changes required to the clauses and whether certain new charges should be removed or allowed. IDA is currently reviewing the remaining new charges proposed by OpenNet and will inform the industry of the outcome of the review at a later date.

#### SCHEDULE 15 – MODIFICATION REQUIRED

IDA Directed Modifications: To ensure clarity and consistency among the provisions of the ICO, IDA directs OpenNet to ensure consistency in its usage of defined terms. Without limitation to the foregoing, IDA notes that "Cost-Oriented Basis" is a defined term in Schedule 18, whereas there are numerous references to "cost-oriented basis" and "cost-oriented" throughout this Schedule 15. Where applicable, OpenNet should ensure consistent usage of the term "Cost-Oriented Basis".

# [ON 11 Apr 12 : Amended as per IDA's Direction.]

Arising from the directed modifications to the ICO, IDA understands that there may be consequential changes required to Schedule 15 (e.g., adjustment to the charges and additional charges for new service option). Accordingly, IDA directs OpenNet to propose, for IDA's approval, such consequential modifications as may be necessary based on the above.

#### **GENERAL:**

- (a) The Parties agree to pay the following Charges where applicable in accordance with clauses 5 & 6 of the main body of this ICO Agreement, and the Billing and settlement requirements set out in Schedule 16.
- (b) Except where otherwise indicated, if Charges are expressed to be estimates in this Schedule or elsewhere in this ICO Agreement, OpenNet reserves the right to adjust these Charges from time to time subject to approval from the Authority, and the Parties agree to pay the Charges as adjusted from time to time.
- (c) For the avoidance of doubt, if OpenNet incurs additional costs in relation to the provision of Mandated Services to the Requesting Licensee which cannot otherwise

be recovered by OpenNet as a Charge under Schedule 15, OpenNet may recover these costs from the Requesting Licensee in accordance with the procedures set out in the relevant Schedule.

(d) Where OpenNet has to determine Charges payable by the Requesting Licensee in this Schedule 15 on a one-time and case-by-case basis, OpenNet shall determine the Charges in accordance with the provisions of this ICO Agreement. Where the Requesting Licensee disputes OpenNet's determination of such Charges, the parties shall resolve such dispute in accordance with Schedule 17 of the ICO Agreement.

#### 1. RESIDENTIAL END-USER CONNECTION

#### 1.1 General

- 1.1.1 Detailed information on the service offerings for the Residential End-User Connection can be found in Schedule 1 of this ICO Agreement.
- 1.1.2 The charges listed below are the rates payable for the Residential End-User Connection applicable to both GPON with splitter and OE with active equipment, and are applicable regardless of whether the Residential End-User Connection is provided by the 1<sup>st</sup> or 2<sup>nd</sup> fibre strand.

# 1.2 Monthly Recurring Charge Per End-User Connection

# 1.3 Installation Charge

1.3.1 There shall be a one-time Installation Charge payable for per Residential End-User Connection. However, the Installation Charge will be waived unless the home-owner had refused entry to OpenNet's staff or agent the first time. The Installation Charge below applies to per connection where the homes were passed. For the avoidance of doubt, there shall be no one-time Installation Charge payable for the 2<sup>nd</sup> fibre strand of the First Termination Point, and no Onsite Charges payable for the installation of the 2<sup>nd</sup> fibre strand of the First Termination Point.

#### **CLAUSE 1.3.2 – MODIFICATION REQUIRED**

1.3.2 The Installation Charge comprises of the charge payable for the Patching Service within the Building MDF Room, onsite manpower charges and cable drop from DP to First Termination Point.

IDA Directed Modifications: IDA refers OpenNet to its directed modifications in section 7 of the Explanatory Memorandum to this Direction. As stated in the Explanatory Memorandum, it is possible that a Residential Premise can exist within a building that is also used for Non-Residential purpose. In this regard, OpenNet proposed modifications would therefore run contrary to the above. Accordingly, IDA requires OpenNet to reinstate the term "Non-Residential Building" in clause 1.3.2. [ON 11 Apr 12 : Amended as per IDA's Direction.]

#### **CLAUSE 1.3.3 – MODIFICATION REQUIRED**

1.3.3 There shall be a one-time Installation Charge payable for the Second Termination Point.

IDA Directed Modifications: IDA refers OpenNet to its directed modifications to clause 19 of Schedule 1. Accordingly, IDA directs OpenNet to propose, for IDA's approval, modifications to clause 1.3.3. of this Schedule 15 as a consequence of amendments to clause 19 of Schedule 1. [ON 11 Apr 12: Amended as per IDA's Direction.]

IDA refers OpenNet to its directed modifications in section 7 of the Explanatory Memorandum to this Direction. As stated in the Explanatory Memorandum, it is possible that a Residential Premise can exist within a building that is also used for Non-Residential purpose. IDA noted that the proposed new clause 1.3.3 does not address the above scenario. Accordingly, IDA requires OpenNet to propose, for IDA's approval, modifications to clause 1.3.3. to clarify on the above scenario.

#### CLAUSE 1.3.4 – MODIFICATION REQUIRED

1.3.4 The Installation Charge do not include TP removal <u>and</u>, site reinstatement, <u>overtime</u> Charges (After Office Hours, Weekends and Public Holidays), non-standard installations (eg. special trunking, scaffolding), access fees or other fees specifically described.

IDA Directed Modifications: Clause 1.3.4 lists several Charges that are purportedly not included in the Installation Charge. Having carefully considered the Charges listed, IDA is of the view that the following Charges should not be included under this clause 1.3.4, for the reasons set out below:

- (a) "overtime Charges" the Installation Charge (see clause 1.3.2) already includes onsite manpower charges which should already allow OpenNet to recover any charges for overtime work;
- (b) "non-standard installation" Charges OpenNet only offers standard installations under the ICO;
- (c) "access fees" these should be borne by OpenNet as part of its obligation to secure the necessary access to buildings; and
- (d) "other fees specifically described" IDA considers that this term is vague and may give rise to confusion amongst the industry, as its meaning is uncertain.

Accordingly, IDA directs OpenNet to propose, for IDA's approval, modifications to clause 1.3.4 to remove the above Charges from clause 1.3.4. [ON 11 Apr 12 : Amended as per IDA's Direction.]

#### CLAUSE 1.4 – MODIFICATION REQUIRED

# 1.4 Patching Charge in the CO and MDF Room

1.4.1 An additional Patching Charge in addition to the Installation Charge will be imposed if patching is required at OpenNet's FDF in the Central Office-and/or MDF Room, wherever necessary. This patching service will be performed automatically if required. Requesting Licensees will not be required to request separately for this service. This will be charged at S\$40 per Patch Cable for patching in the CO and S\$160<sup>[To be reviewed by IDA]</sup> per Patch Cable for patching in the MDF Room, irrespective of whether there are one (1) or two (2) patch points per Patch Cable.

1.4.3 The deactivation of the Patching Service and/or the removal of the relevant Patch Cable will be charged on a per Patch Cable basis, irrespective of whether there are one (1) or two (2) patch points per Patch Cable. The amount payable will depend on the Patching Location.

IDA Directed Modifications: IDA refers OpenNet to section 2 of the Explanatory Memo to this Direction, and accordingly directs OpenNet to propose, for IDA's approval, modifications to clause 1.4 in the manner set out therein. [ON 11 Apr 12 : Amended as per IDA's Direction.]

#### 1.5 Installation of Internal Cabling Charge

1.5.1 OpenNet may levy a charge for installation of internal cabling that exceeds fifteen (15) metres, measured from the point of entry to the Residential Premise to the First Termination Point, at S\$33 per five (5) metres.

# **CLAUSE 1.5.2 – TO BE REVIEWED**

1.5.2 OpenNet may levy a charge for installation of internal cabling that exceeds fifteen (15) metres, measured from the point of entry to the Residential Premise to the Second Termination Point, at S\$33<sup>[To be reviewed by IDA]</sup> per five (5) metres.

#### 1.6 Onsite Charges

1.6.1 OpenNet will charge for every onsite visit according to the time spent by OpenNet's staff. There will be a minimum charge of S\$130 per visit per staff up to the first two hours. Subsequent hour blocks spent will be charged according to the rates listed below.

# 1.7 Cancellation Charge

- 1.7.1 OpenNet will charge for cancellation of any Request submitted by the Requesting Licensee before the RFS date.
- 1.7.2 The Cancellation Charge shall be at the same rate as the Installation Charge and the charge for installation of internal cabling exceeding fifteen (15) metres (where applicable) for the requested service.
- 1.7.3 If OpenNet fails to repair an installation-related fault within seventy-two (72) hours from the commencement of the joint investigation (as set out in Clause 6A of Schedule 1), the Requesting Licensee may elect to cancel such faulty Residential End-User Connection. OpenNet shall waive the cancellation charge if the Requesting Licensee submits OpenNet's standard cancellation form to OpenNet after seventy-two (72) hours from the commencement of the joint investigation but before the fault is rectified.

# 1.8 Pre-mature Termination Charge

1.8.1 Pre-mature termination of service contracts will be liable to charges at 100% of the remaining contractual value.

#### CLAUSE 1.9 - APPROVED

#### 1.9 No Fault Found Charge

1.9.1 No Fault Found will be charged at S\$280 per report.

#### **CLAUSE 1.10 – MODIFICATION REQUIRED**

# 1.10 Joint Investigation Charge

1.10.1 OpenNet will charge for every joint investigation visit <a href="where applicable">where applicable</a> according to the time spent by OpenNet's staff. There will be a minimum charge of S\$130 per visit per staff up to the first two hours. Subsequent hour blocks spent will be charged according to the rates listed below.

IDA Directed Modifications: IDA had previously required OpenNet to propose an outcome-based fault investigation process such that if a particular fault is due to OpenNet, no joint investigation charge should be imposed on the affected Requesting Licensee. Accordingly, IDA directs OpenNet to propose, for IDA's approval, modifications to clause 1.10 to expressly give effect to the requirement above. Without limitation to the above, OpenNet should clarify that it will not charge for every joint investigation visit. For example, OpenNet may replace the words "OpenNet will charge for every joint investigation" with "OpenNet will charge for a joint investigation visit where applicable". [ON 11 Apr 12: Amended as per IDA's Direction.]

#### 1.11 Redundancy Service Charges

1.11.1 OpenNet will provide Redundancy Service at the same Monthly Recurring Charge listed above.

#### CLAUSE 1.12 – MODIFICATION REQUIRED

# 1.12 Express Service Activation Request Charge

**1.12.1** The Requesting Licensee is required to pay the sum of S\$55<sup>[To be reviewed by IDA]</sup> for each Request for express service activation in addition to such sum payable for installation.

1.12.2 In the event, OpenNet is unable to provision an express service within the stipulated time due to OpenNet's fault, the Requesting Licensee will not be required to pay the Express Service Activation Request Charge.

IDA Directed Modifications: IDA refers OpenNet to its directed modifications to clause 6.11 of Schedule 1, in particular, where IDA directs OpenNet to propose how it would address the situation where it is not able to provision an express service within the stipulated timeline due to OpenNet's fault.

Accordingly, IDA directs OpenNet to propose, for IDA's approval, modifications to this clause 1.12 as a consequence of amendments to clause 6.11 of Schedule 1. [ON 11 Apr 12 : Amended as per IDA's Direction.]

#### CLAUSE 1.13 – MODIFICATION REQUIRED

- 1.13 Cancellation Charge under Express Service Activation
- **1.13.1** The Cancellation Charge shall consist of such sum payable had the installation took place plus a sum of  $S$55^{[To be reviewed by IDA]}$ .
- 1.13.2 In the event OpenNet is unable to provision an express service within the stipulated time due to OpenNet's fault, the Requesting Licensee will not be charged the additional sum of S\$55.

IDA Directed Modifications: IDA refers OpenNet to its directed modifications to clause 1.12 of this Schedule 15. Depending on the OpenNet's proposal in relation to clause 1.12 above, there may be a need for OpenNet to propose consequential modifications to this clause. Accordingly, IDA directs OpenNet to propose, for IDA's approval, necessary modifications to clause 1.13 as a consequence of amendments to clause 1.12 above. [ON 11 Apr 12: Amended as per IDA's Direction.]

#### CLAUSE 1.14 – MODIFICATION REQUIRED

#### 1.14 Termination Point Relocation, Repair and Replacement, and Removal Charge

1.14.1 The Requesting Licensee <u>shall be liable</u>is <u>required</u> to pay for each Request for relocation, repair, replacement and/or removal of termination points and/or fibre cables within the same premise according to the rates listed below:

1.14.2 For the avoidance of doubt, no charges will be payable where repair and replacement is necessary to rectify any defect or fault solely caused by OpenNet.

IDA Directed Modifications: IDA refers OpenNet to its directed modifications to clause 11.8(d) of Schedule 1, and directs OpenNet to propose, for IDA's approval, modifications to this clause 1.14 as a consequence of the directed modifications to clause 11.8(d) of Schedule 1.

IDA refers OpenNet to its directed modifications in section 7 of the Explanatory Memorandum to this Direction. As stated in the Explanatory Memorandum, it is possible that a Residential Premise can exist within a building that is also used for Non-Residential purpose. IDA noted that the proposed new clause 1.14 does not address the above scenario. Accordingly, IDA requires OpenNet to propose, for IDA's approval, modifications to clause 1.14. to clarify on the above scenario. [ON 11 Apr 12 : Amended as per IDA's Direction.]

#### **CLAUSE 1.15 – MODIFICATION REQUIRED**

1.15 Cancellation Charge under Express Service Activation under Relocation Service within the Same Premise

IDA Directed Modifications: Clause 18.6 of Schedule 1 of OpenNet's Draft Revised ICO states that there shall be no Express Service Activation for a Request for Relocation Service. The current wording of clause 1.15 is therefore inconsistent with the terms of clause 18.6 of Schedule 1.

Accordingly, IDA directs OpenNet to remedy this inconsistency. For example, to fulfil this requirement, OpenNet may replace the text of clause 1.15 with the words "Cancellation Charge under Relocation Service within the Same Premise". [ON 11 Apr 12: Amended as per IDA's Direction.]

**1.15.1** In the event that the Requesting Licensee decides to cancel its Request before the RFS date, the Requesting Licensee shall be liable to pay all incidental costs and/or expenses which are reasonably incurred by OpenNet in connection with the cancelled Request (to be recovered on a cost-oriented basisCost-Oriented Basis).

#### **CLAUSE 1.16 – MODIFICATION REQUIRED**

#### 1.16 Missed Appointment Charge

1.16.1 In the event that the Requesting Licensee fails to inform OpenNet of the changes in the appointment date/time and OpenNet's Contractor has reached the residential premises at the appointed date/time, the Requesting Licensee shall be liable to the missed appointment charge of S\$50<sup>[To be reviewed by IDA]</sup>.

IDA Directed Modifications: IDA refers OpenNet to section 12 of the Explanatory Memo. In particular, IDA had directed OpenNet to remove its proposed Missed Appointment Charges from its Draft Revised ICO. Accordingly, IDA directs OpenNet to propose, for IDA's approval, modifications to clause 1.16 to comply with the above. [ON 11 Apr 12: Amended as per IDA's Direction.]

#### CLAUSE 1.17 – MODIFICATION REQUIRED

- 1.17 Relocation Service of Residential End-User Connection From One Residential Address to Another Residential Address Charge
- 1.17.1 The Requesting Licensee is required to pay a one-time Relocation Service Charge of S\$67.52<sup>[To be reviewed by IDA]</sup> in addition to such sum payable for installation, activation and deactivation of Patching <u>Service</u> in the CO and MDF room.

IDA Directed Modifications: IDA refers OpenNet to section 2 of the Explanatory Memorandum to this Direction. In particular, IDA had required OpenNet to remove its proposed new charges relating to patching in the MDF Room and the deactivation of the patching service and/or removal of the relevant patch cable. The exception to the above will be the deactivation of the patching service and/or removal of the relevant patch cable in the MDF Room during the relocation of services to a different premise.

Accordingly, IDA directs OpenNet to propose, for IDA's approval, modifications to clause 1.17 in order to ensure that OpenNet's proposed relocation service charge meets IDA's requirements as stated above. [ON 11 Apr 12 : Amended as per IDA's Direction.]

- 1.18 Cancellation Charge under Relocation Service of Residential End-User

  Connection From One Residential Address to Another Residential Address

  Charge
- 1.18.1 In the event that the Requesting Licensee decides to cancel its Request before the RFS date, the Requesting Licensee shall be liable to pay all incidental costs and/or expenses which are reasonably incurred by OpenNet in connection with the cancelled Request, said costs and/or expenses to be recovered on a Cost-Oriented Basis.

[ON 11 Apr 2012 : The cancellation charge is stated under Schedule 1. ON would like to propose adding the cancellation clause 1.18.1 for better clarity of what the cancellation charges entail.]

#### CLAUSE 1.18 – MODIFICATION REQUIRED

- 1.18 Cancellation / Missed Appointment Charge of Fault Reported
- 1.18.1 There shall be a one-time Cancellation/Missed Appointment Charge payable per fault reported in the event the Requesting Licensee cancels or fails to inform OpenNet of the changes in the appointment date/time.

IDA Directed Modifications: IDA refers OpenNet to section 12 of the Explanatory Memo. In particular, IDA had directed OpenNet to remove its proposed Missed Appointment Charges from its Draft Revised ICO. Accordingly, IDA directs OpenNet to propose, for IDA's approval, modifications to clause 1.18 to comply with the above. [ON 11 Apr 12: Amended as per IDA's Direction.]

#### 2. NON-RESIDENTIAL END-USER CONNECTION

#### 2.1 General

- 2.1.1 Detailed information on the service offerings for the Non-Residential End-User Connection can be found in Schedule 2 of this ICO Agreement.
- 2.1.2 The charges listed below are the rates payable for the Non-Residential End-User Connection applicable to both GPON with splitter and OE with active equipment.
- 2.1.3 For the avoidance of doubt, all charges in this Section 2 apply on a per connection basis.

#### **CLAUSE 2.2 – TO BE REVIEWED**

#### 2.2 Monthly Recurring Charge Per End-User Connection

# 2.3 Installation Charges

2.3.1 The one-time Standard Installation Charge includes charges for Patching Service at the Building MDF Room and onsite manpower charges.

#### **CLAUSE 2.3.2 – MODIFICATION REQUIRED**

2.3.2 Where requested by the Requesting Licensee, the Installation of Network Charge shall be payable for the installation of vertical fibre / in-building cabling, ducting and/or enclosure and/or cable tray from the FTTB Node to the TP in the vertical telecommunication riser or 1<sup>st</sup> TP of the Non-Residential Premise.

IDA Directed Modifications: IDA has reviewed OpenNet's proposed changes to clause 2.3.2 and notes that it is contrary to OpenNet's earlier position that it would install the cable tray where required. Accordingly, IDA directs OpenNet to propose, for IDA's approval, modifications to this clause 2.3.2 to reinstate the item of cable tray. [ON 11 Apr 12: Amended as per IDA's Direction.]

#### **CLAUSE 2.3.3 – MODIFICATION REQUIRED**

2.3.3 For avoidance of doubt, the Installation of Network Charge shall be payable for the installation of vertical fibre / in-building cabling from the FTTB Node to each additional Termination Point of the Non-Residential Premise. The Standard Installation Charge and Installation of Network Charge do not include TP removal and, site reinstatement., overtime Charges (After Office Hours, Weekends and Public Holidays), non-standard installations (eg. special trunking, scaffolding), access fees or other fees specifically described.

IDA Directed Modifications: Clause 2.3.3 lists several Charges that are purportedly not included in the Installation Charge. Having carefully considered the Charges listed, IDA is of the view that the following Charges should not be included under this clause 2.3.3, for the reasons set out below:

- (a) "overtime Charges" the Installation Charge (see clause 2.3.1) already includes onsite manpower charges which should already allow OpenNet to recover any charges for overtime work;
- (b) "non-standard installation" Charges OpenNet only offers standard installations under the ICO;
- (c) "access fees" these should be borne by OpenNet as part of its obligation to secure the necessary access to buildings; and
- (d) "other fees specifically described" IDA considers that this term is vague and may give rise to confusion amongst the industry, as its meaning is uncertain.

Accordingly, IDA directs OpenNet to propose, for IDA's approval, modifications to clause 2.3.3 to remove the above Charges from clause 2.3.3. [ON 11 Apr 12 : Amended as per IDA's Direction.]

#### **CLAUSE 2.3.4 – MODIFICATION REQUIRED**

2.3.4 The deactivation of the Patching Service and/or the removal of the relevant Patch Cable will be charged on a per Patch Cable basis, irrespective of whether there are one (1) or two (2) patch points per Patch Cable. The amount payable will depend on the Patching Location.

Accordingly, IDA directs OpenNet to propose, for IDA's approval, modifications to this clause 2.11 as a consequence of amendments to clauses 6.14 and 6.15 of Schedule 2. [ON 11 Apr 12 : Amended as per IDA's Direction.]

#### **CLAUSE 2.12 – MODIFICATION REQUIRED**

- **2.12.1** The Cancellation Charge shall consist of such sum payable had the installation took place plus a sum of  $S$150^{[To be reviewed by IDA]}$ .
- 2.12.2 In the event where OpenNet is unable to provision an express service within stipulated time due to OpenNet's fault, Requesting Licensee will not be charged the additional sum of S\$150.

Accordingly, IDA directs OpenNet to propose, for IDA's approval, modifications to this clause 2.12 as a consequence of amendments to clause 2.11 above. #### CLAUSE 2.13 – MODIFICATION REQUIRED

#### 2.13 Termination Point Relocation, Repair & Replacement, or Removal Charge

2.13.1 The Requesting Licensee <u>shall be liable</u>is required to pay for each Request for relocation, repair & replacement or removal of termination points and/or fibre cables all within the same premise for the same End-User according to the rate listed below.

propose, for IDA's approval, modifications to this clause 2.13 as a consequence of the directed modifications to clause 11.8(d) of Schedule 2. [ON 11 Apr 12 : Amended as per IDA's Direction.]

#### **CLAUSE 2.14 – MODIFICATION REQUIRED**

2.14 Cancellation Charge under Express Service Activation under Relocation Service within the Same Premise

[ON Comment 11 Apr 12 : Digging & trenching work areis works over and above the standard installation methods and required additional more costly effort. OpenNet notes IDA recognises this fact. 9.3.1 The Standard Installation Charge includes charges for Patching Service at the Building MDF Room and onsite manpower charges.

- 12.1.2 The charges listed below are applicable for Co-Location Service in the Central Office.

## 12.2 Co-location Space

- 12.2.1 Depending on the term of the licence requested by the Requesting Licensee, different monthly rates shall be payable. This cost is charged based on the total equipment footprint, provided always that the Requesting Licensee has complied fully with all the requirements contained in Schedule 12. For avoidance of doubt, the total equipment footprint shall be rounded up to the next whole unit.
- 12.2.2 The respective rates for the different length of terms are listed in the table below.

- · Transmission Tie Cable;

- · Gas suppression system (FM200 or similar);
- · Security for Central Office (24 hours a day, 7 days a week); and
- · Security card access system.

#### **CLAUSE 12.3 – MODIFICATION REQUIRED**

## 12.3 Power Charges

12.3.1 OpenNet will provide a minimum of 16 fused amp for AC and 20 fused amp for DC to the Requesting Licensee at the rate below.

#### **CLAUSE 12.7 – MODIFICATION REQUIRED**

## 12.7 Onsite Charges

12.7.1 OpenNet will provide supervision of onsite work and escort services. This service will be charged according to the time spent by OpenNet's staff. The detailed breakdown of the rates are listed in the table below.

<u>42.7.212.7.3</u> In addition to the charges stated above, the Requesting Licensee will have to reimburse OpenNet for the transport claims of its staff.

IDA Directed Modifications: A comment was made that, in cases where a Requesting Licensee requests for supervision of onsite work and escort services during Office Hours, and the service extends beyond Office

Hours due to the fault of OpenNet, OpenNet should only be entitled to impose charges based on the original requested timing.

After careful consideration, IDA considers it reasonable that Requesting Licensees should not be made to pay additional charges for services that extend beyond the original requested timing, where the overrun is due to the fault of OpenNet.

Accordingly, IDA directs OpenNet to propose, for IDA's approval, modifications to clause 12.7 to state that, where supervision of onsite work and escort services are being provided by OpenNet, and such supervision/services extend beyond the original requested timing solely due to OpenNet being late for the appointment and/or other reasons attributable to OpenNet, OpenNet shall only impose charges based on the original requested timing. [ON 11 Apr 12: Amended as per IDA's Direction.]

## 12.8 Physical Access/ Emergency Physical Access Charge

12.8.1 This Charge will be <u>cost-oriented on a Cost-Oriented Basis</u> and determined on a case-by-case basis depending on the necessary work scope.

#### 12.13 Reconnection Charge

- 12.13.1 The Reconnection Charge will be applicable in the event of the lifting of suspension of the ICO Agreement or Schedule 12 (unless OpenNet was responsible for the said suspension), and will be charged on a per request per Central Office basis.
- 12.13.2 This Charge will be <u>cost-oriented on a Cost-Oriented Basis</u> and calculated on a case-by-case basis depending on the necessary work scope.

### 12.14 Fibre Splicing Charge

12.14.1 The Fibre Splicing Charge is applicable for termination of the Transmission Tie Cable at the Requesting Licensee's FDF in its Co-location Space.

- **12A.4.1** Site Preparation & Installation will include site preparation work (M&E works); setting up direct connections between two Requesting Licensees and charges for acquiring permits (where necessary) from the Fire Safety Bureau and Building & Construction Authority.
- **12A.4.2** This Charge will be <u>cost oriented on a Cost-Oriented Basis</u> and calculated on a case-by-case basis depending on the necessary work scope.

### **CLAUSE 12A.5 – MODIFICATION REQUIRED**

## 12A.5 Onsite Charges

**12A.5.1** OpenNet will provide supervision of onsite work and escort services. This service will be charged according to the time spend by OpenNet's staff. The detailed breakdown of the rates are listed in the table below.

12A.5.2 Where such supervision/services extend beyond the original requested timing solely due to OpenNet being late for the appointment and/or other reasons attributable to OpenNet, OpenNet will only impose charges based on the original requested timing.

12A.5.32 In addition to the charges stated above, the Requesting Licensee will have to reimburse OpenNet for the transport claims of its staff.

IDA Directed Modifications: A comment was made that, in cases where a Requesting Licensee requests for supervision of onsite work and escort services during Office Hours, and the service extends beyond Office Hours due to the fault of OpenNet, OpenNet should only be entitled to impose charges based on the original requested timing.

After careful consideration, IDA considers it reasonable that Requesting Licensees should not be made to pay additional charges for services that extend beyond the original requested timing, where the overrun is due to the fault of OpenNet.

Accordingly, IDA directs OpenNet to propose, for IDA's approval, modifications to clause 12A.5 to state that, where supervision of onsite work and escort services are being provided by OpenNet, and such supervision/services extend beyond the original requested timing solely due to OpenNet being late for the appointment and/or other reasons attributable to OpenNet, OpenNet shall only impose charges based on

the original requested timing. <u>[ON 11 Apr 12 : Amended as per IDA's Direction.]</u>
